## Waste Paint

<p><b>HOUSEHOLD PAINT Covered by Product Care Program (container no larger than 20 litres – no limit for Product Care Paints)</b></p> <ul style="list-style-type: none"> <li>• Interior and Exterior latex and oil based consumer paint</li> <li>• Deck and floor coating</li> <li>• Wood stains</li> <li>• Varnish and urethane (single compound)</li> <li>• Concrete and masonry paint</li> <li>• Drywall paint</li> <li>• Undercoats and primers</li> <li>• Stucco paint</li> <li>• Marine paint (unless registered under Pest Control Products Act)</li> <li>• Melamine, metal and anti-rust paint, stain and shellac</li> <li>• Swimming pool pain (single component)</li> <li>• Stain blocking paint</li> </ul>	<p><b>OTHER PAINT PRODUCTS (limit of 12 litres)</b>  <b>OVERLIMIT CHARGE of \$2.00/Litre</b></p> <ul style="list-style-type: none"> <li>• Unlabelled paint</li> <li>• Rusted cans</li> </ul> <p>The following paint products are - \$3.00/Litre</p> <ul style="list-style-type: none"> <li>• Automotive Paint</li> <li>• Industrial Paint</li> <li>• Epoxy</li> <li>• Craft Paint</li> </ul>

<ul style="list-style-type: none"> <li>• Textured paint</li> <li>• Block filler</li> <li>• Wood, masonry, driveway sealer or water repellent (non-tar based or bitumen based)</li> <li>• LABELLED Empty paint cans</li> </ul>	
<b>AEROSOL PAINT (50 Can limit)</b> <ul style="list-style-type: none"> <li>• Automotive</li> <li>• Craft</li> <li>• Industrial</li> </ul>	

### Aerosol Cans (non-paint)

<b>Household Aerosols (10 can limit, over limit \$1.00/can)</b> <ul style="list-style-type: none"> <li>• Bug repellent</li> <li>• Crack filler</li> <li>• Cleaners</li> <li>• Insecticides (ie Raid)</li> <li>• Bear spray cans - \$5.00/can</li> </ul>

### Pesticides (Liquids or Solid)

<b>Liquid Pesticides (Domestic) covered by Produce Care Program</b>  Acceptable pesticides must have: <ul style="list-style-type: none"> <li>• The poison symbol (skull and crossbones)</li> <li>• A Pest Control Product (PCP) number and</li> <li>• The word domestic on the label</li> </ul> Max container size is 10 Litres Unlimited number of containers accepted if it meets above requirements	<b>Other domestic pesticides not covered by Product Care Program (over 4 L or 4 Kg limit)</b> <ul style="list-style-type: none"> <li>• Anything liquid over 4 Litres is charged \$3.50/Litre</li> <li>• Solid pesticides over 4 Kg is charged \$3.50/kg</li> </ul> <b>NO commercial, agricultural pesticides</b> <b>NO empty pesticide containers (rinse and throw in garbage)</b>

## Flammables (solids or liquids)

<p><b>Flammable Liquids (contains flammable symbol or phrase “keep away from open spark or flame. Examples Include:</b></p> <ul style="list-style-type: none"><li>• Acetone</li><li>• Camp fuel</li><li>• Furniture stripper</li><li>• Kerosene</li><li>• Flammable degreasers</li><li>• Flammable lubricants</li><li>• Methanol</li><li>• Mineral spirits</li><li>• Paint stripper</li><li>• Paint thinner</li><li>• Turpentine</li><li>• Varsol</li><li>• Other solvents</li></ul> <p>Max container size is 10 litres No limit to number of containers</p>	<p><b>Flammable Solids (not covered by Product Care Program – 4 L limit) Over limit \$2.50/Litre</b></p> <p>Examples include:</p> <ul style="list-style-type: none"><li>• Adhesives</li><li>• Roof patch</li></ul>
<p><b>Gasoline</b> Must be in an approved ULC container (Jerry can). Container will not be returned to customer at drop off</p> <p>Max container size is 25 litres</p>	

## Corrosives

<p><b>Household Cleaners (4 litre limit – over limit charge \$3.50/litre). Examples include:</b></p> <ul style="list-style-type: none"><li>• Bleach, ammonia</li><li>• Solid (Comet), semi-solid (floor wax), liquid (Mr. Clean) cleaners</li><li>• Grout, window and furniture cleaner</li><li>• Wood cleaner and strippers</li><li>• Rust, calcium and lime removers</li><li>• Metal cleaners</li><li>• Degreasers</li><li>• All-purpose cleaners (ie. Vim, Lysol etc.)</li></ul>

## Oxidizers (Pool Chemicals)

(4 Litre or 4 Kg limit – overlimit is \$5.00/litre or kg)

Examples include:

- Pool and hot tube chemicals such as chlorine

## Other Acceptable Categories

- Fertilizers - Solid fertilizer (1-kilogram limit – over \$2.00 per kilogram)
- Liquid fertilizer (4-litre limit over \$1.00 per litre)
- Sealants, caulking
- Solid adhesives (eg. powdered mortar and grout)
- Fillers (eg. wood, drywall, concrete)
- Mercury Thermostats

***Please note: the Battery Doctors will not accept any empty containers (except empty paint cans) or liquid products that are solidified, these items can go in your regular garbage. Materials in glass containers cannot be accepted for safety reasons unless they are pesticides in the original container. As well, the following products are not accepted:***

**Ammunition, Flares, Explosives**

**Automotive cleaners or polishes**

**Asbestos products**

**Pharmaceuticals**

**Cyanide**

**Diesel Fuel, Oil**

**Radioactive waste**

**Agricultural Pesticides**

**Biomedical waste**
